Know all by these presents, that the undersigned's hereby makes, constitutes and appoints each of Francis F. Lee and Russell J. Knittel as the undersigned's true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:
